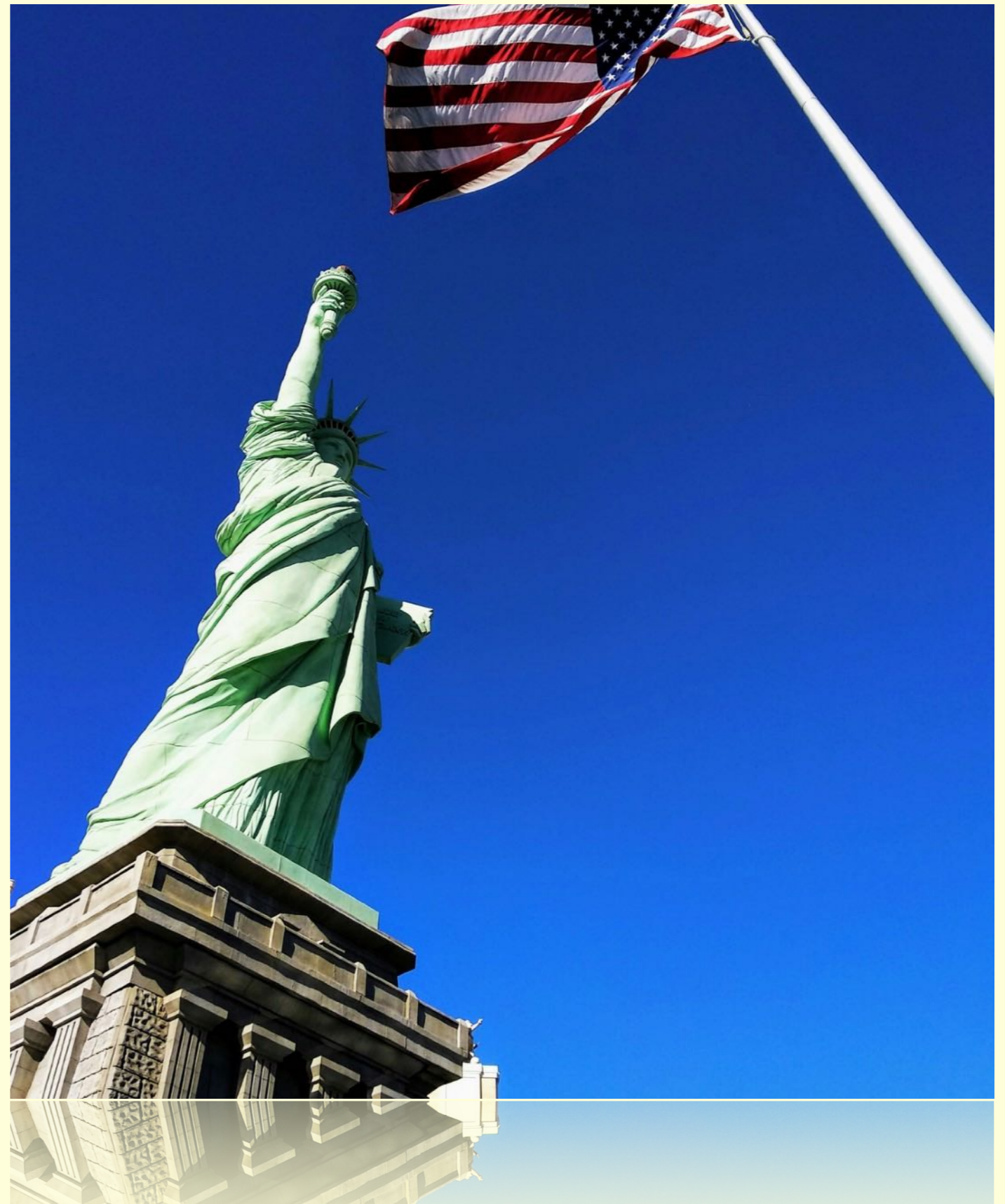

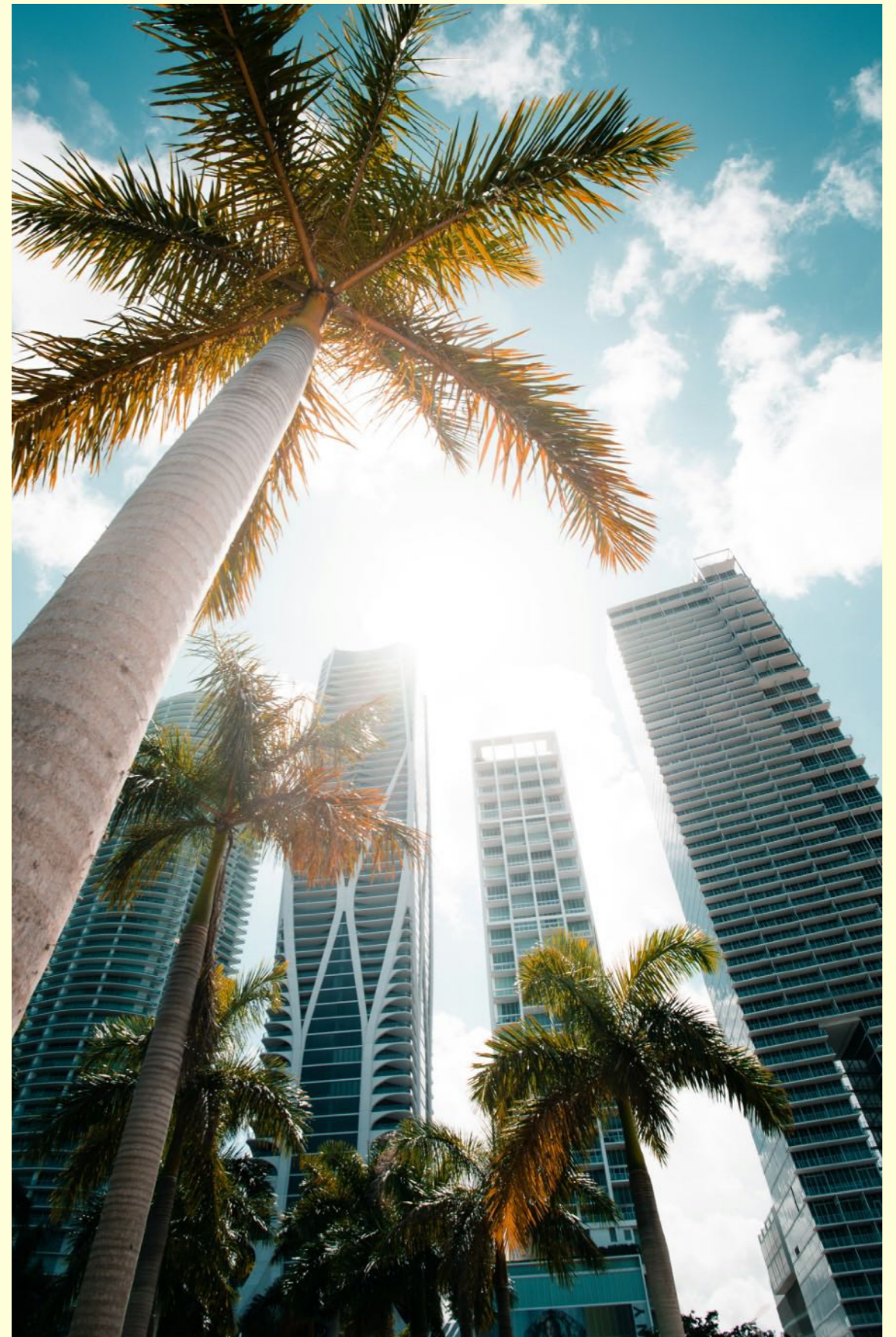


Overview

The E-2 visa presents a favorable avenue for individuals seeking to establish or acquire a business within the United States. It requires an investment in the business. This allows the visa holder and their family to reside and work in the United States.

While the principal applicant can only work for the E-2 business, the spouse can obtain employment authorization and work for any employer in the US.

The E-2 visa can be renewed indefinitely as long as the E-2 company remains active and is engaged in business as described.



Who is eligible for an E-2 Investor Visa?

To qualify for E-2 classification, the treaty investor must:

- Be a national of a country with which the United States maintains a treaty
- Have invested, or be actively in the process of investing, a substantial amount of capital in a bona fide enterprise in the United States
- The US company may not be marginal
- Be seeking to enter the United States solely to develop and direct the investment enterprise.
- Hold at least 50% ownership of the enterprise or possession of operational control through a managerial position or other corporate device.
- The US company must be bona fide

What is a substantial amount?

- Substantial in relationship to the total cost of either purchasing an established enterprise or establishing a new one
- Sufficient to ensure the treaty investor's financial commitment to the successful operation of the enterprise

What is a bona fide company?

A bona fide enterprise refers to a real, active, and operating commercial or entrepreneurial undertaking which produces services or goods for profit. It must meet applicable legal requirements for doing business within its jurisdiction.

What is a marginal?

The investment enterprise may not be marginal. A marginal enterprise is one that does not have the present or future capacity to generate more than enough income to provide a minimal living for the treaty investor and his or her family. Depending on the facts, a new enterprise might not be considered marginal even if it lacks the current capacity to generate such income. In such cases, however, the enterprise should have the capacity to generate such income within five years from the date that the treaty investor's E-2 classification begins.

Period of Stay

Qualified treaty investors in general will be issued a visa at an US consulate/embassy for 2 to 5 years. Visa issue terms depends on reciprocity of the treaty country and the United States.

There is no limit to the number of renewals an E-2 Investor may be granted.

Family of E2 principal

Treaty investors may be accompanied or followed by spouses and unmarried children who are under 21 years of age. Their nationalities need not be the same as the treaty investor. Spouses and children may seek E-2 nonimmigrant classification as dependents and, if approved, generally will be granted the same period of stay as the principal.

Spouse of E2 principal

Spouse of an E2 principal are allowed to engage in employment in the United States. The spouse may, upon admission to the United States, apply with the DHS for an employment authorization document (EAD), which an employer could use to verify the spouse's employment eligibility.

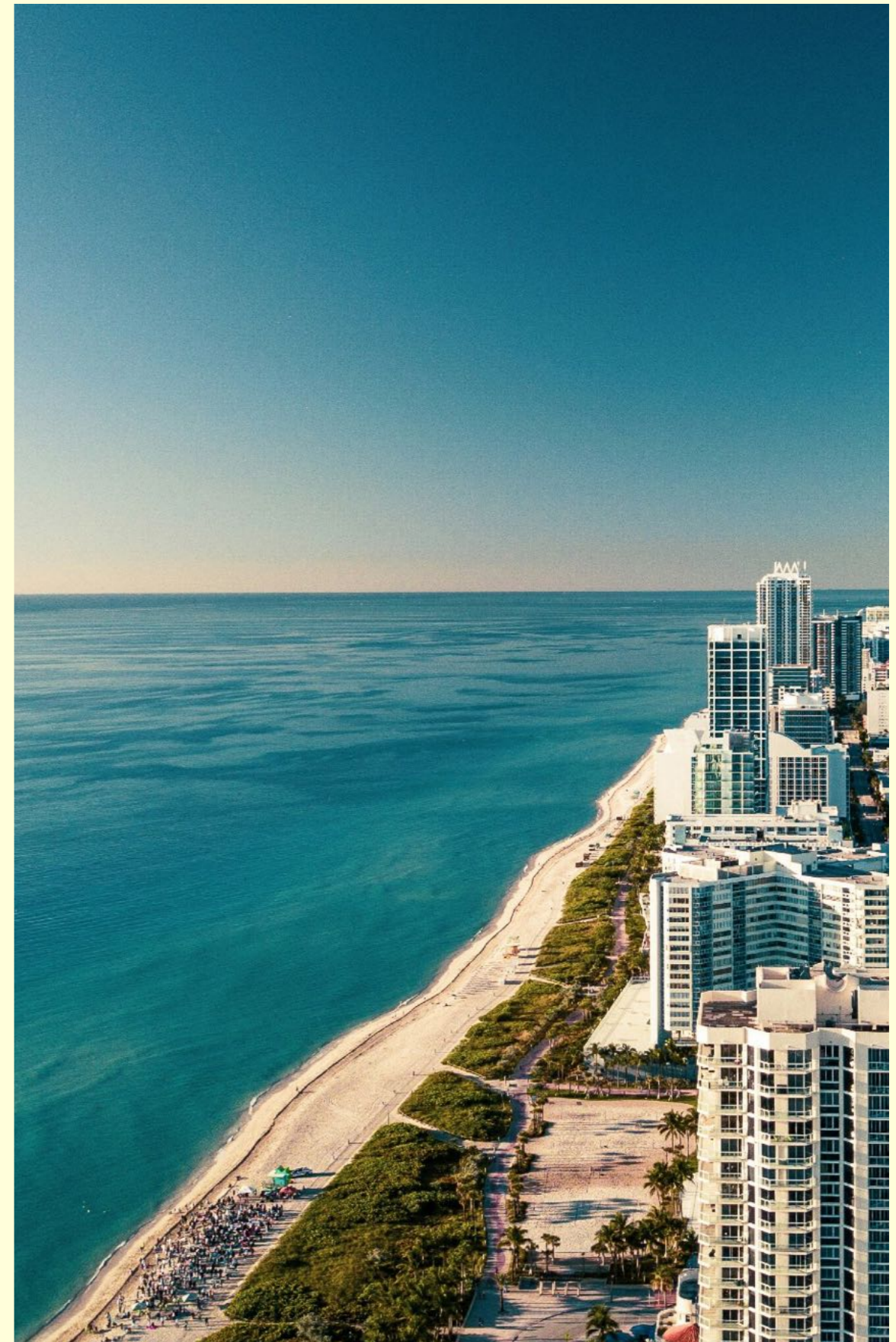
Children of E2 principal

Children under 21 are able to accompany the E2 principal. Dependent children are not legally allowed to work in the United States although they may attend school.

When the children reach 21, they lose their E2 status and must depart the US or change to a different visa category.

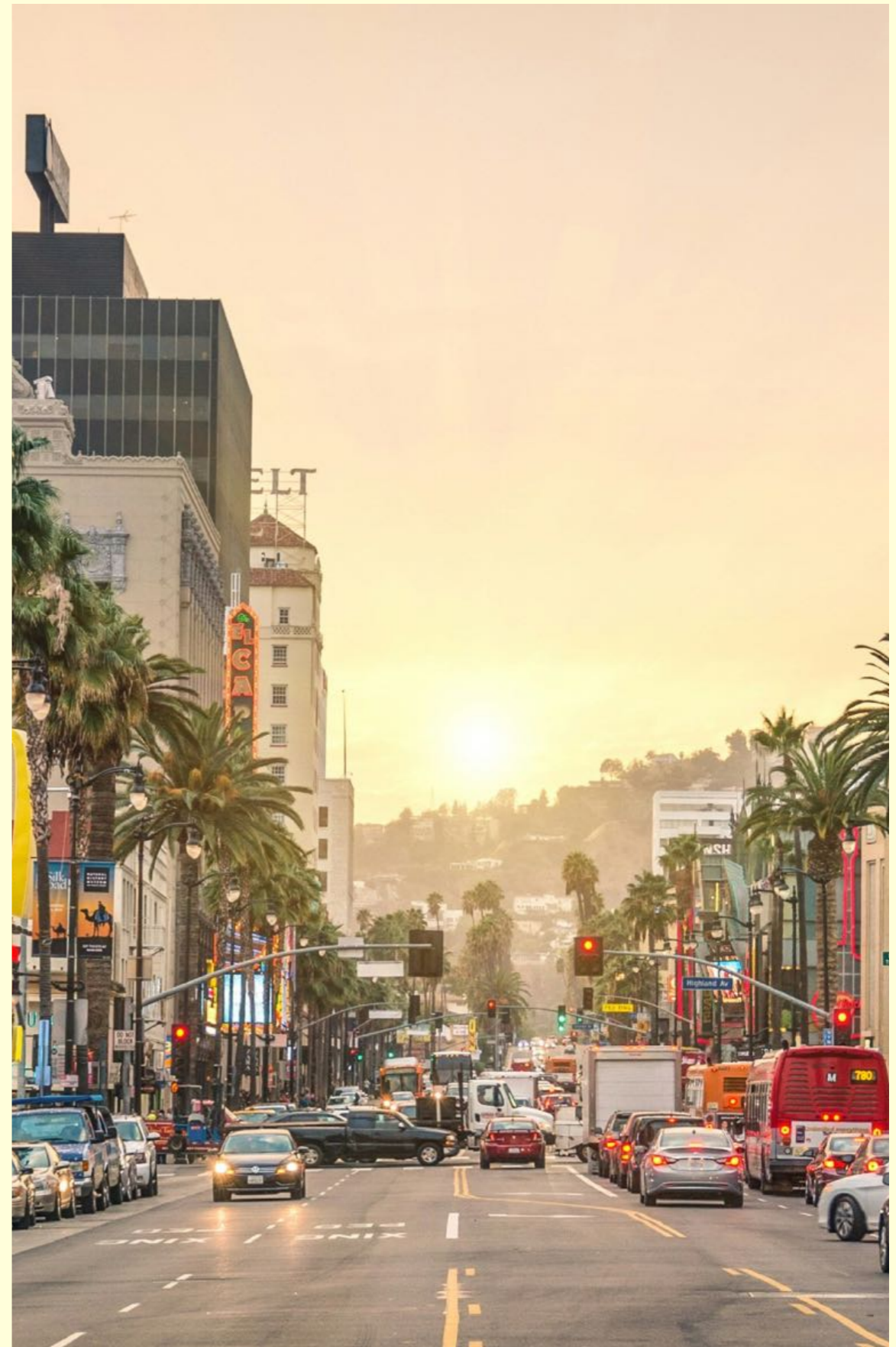
